# INTERSECTIONALITY STUDIES OPENING

Throughout history, people have built social orders by installing power constellations that have had the sole purpose of granting privileges to some and subordinating the many. Access to power grants a privileged access to resources, rights, and to being represented as norm/al. This process also always excludes those who are Othered by the norm from such privileges. This is the motor of social inequality including exploitation, discrimination and violence. Interventions, though, often had a tendency to concentrate on, for example, either racism or sexism only, while reproducing power-coded modes of in- or exclusion. This has led to a silencing of especially Black women and their agencies and was addressed by Black feminism. The corresponding intervention was conceptualized as 'intersectionality' by the Black US-American lawyer and activist Kimberlé Crenshaw from 1989 onwards, and developed by others as well. Ever since then, intersectionality has been used as a prism, a concept, a theory and a mode of transdisciplinary interventions across academic disciplines and in neat intersections of academia and social movements.

The Bayreuth based Doctoral College for Intersectionality Studies PKIS, as funded since 01. December 2022 by the Hans-Böckler-Foundation, aims at building on and strengthening this (trans)disciplinary structure. As the first doctoral college of its kind in Europe, it focusses on analyzing, communicating about and intervening into intersectional social inequalities.

On 13 February 2023 it will launch its work in the course of a public opening workshop in the presence of representatives of academia, activism and the arts.
